Dear All-State Musician,

CONGRATULATIONS on being selected for the 2004 Oregon Music Educator's All-State Honor Groups. We know that your experience will be a great one. The group managers have worked hard to provide you with an excellent conductor; putting together tape screeners; and developing a well-balanced ensemble.

If for some reason you are not going to participate in the group, please let us know at the earliest possible time so an alternate can be placed in your spot.

On the next few pages, you will find a tentative schedule and some expectations. You will also find the paperwork you need to finish and send in before your music can be sent out. You will receive an updated schedule at that time.

Your participation fee of \$220 will cover clinician costs, sheet music, food, lodging, and administrative expenses. Payment can be made by check or purchase order payable to OMEA. **All students will stay at the Eugene Hilton two nights, except for those staying at home or with relatives in the Eugene area.** Attendance for local students (Eugene area) is \$140. These are the only two options in terms of lodging in Eugene—no other arrangements will be allowed. (An additional fee is required to cover the Gresham rehearsal for the jazz ensembles. Watch the OMEA website for details.)

I'm sorry that the November 1 notification date was not made. We have had to work out some details in our first on-line registration.

I look forward to seeing you in Eugene in January.

1. **DO NOT FORGET YOUR MUSIC!** Band & Orchestra students need to bring a music stand.
2. **REMEMBER YOUR CONCERT CLOTHES!** Bring what you wear for your school concerts.
3. **ALL STUDENTS register at the Hilton Hotel, 66 East Sixth Avenue, prior to going to the U of O School of Music.** Students staying in OMEA housing will drop off their luggage in a storage room. If there are problems with room assignments they will be changed during your rehearsal. Do not come to the School of Music with your luggage as there is no place for secure storage.
4. There will be chair auditions for orchestra members. Choir members may be asked to sing their parts. Decisions about chair assignments have been left to the screeners, but there will be some auditions for solo parts.
5. All participants staying at the hotel should remember that all of your **meals have been pre-paid**. Those staying at home or with relatives remember that your lunches and dinners have been pre-paid. Do not plan to go out to eat.
6. Do not leave the School of Music except for meal breaks when you walk to the meal site.
7. Parking in the area of the School of Music is nearly impossible to find. Vehicles parked longer than the posted time will be ticketed. If you are staying at the Hilton, you must use the buses provided.
8. **Attendance will be checked at the start of each rehearsal.** Be on time for all rehearsals. If you become ill, you must communicate this to the site chair or the organizing chair.
9. **Name tags must be worn at all times.**

10. **Do not ask to switch rooms.** It is a tremendous job to get all of you in rooms. Every effort will be made to accommodate your wishes as to roommates.

11. **Please be quiet in the hallways of the hotel.**

12. **Do not use the phone in your room for calls which would have a charge.** Use pay phones in the lobby and call collect.

13. Tickets for the concert will be on sale daily at the Conference Registration Booth. Tickets are \$12 for large groups, and \$8 for the Jazz Night. Make checks payable to OMEA. Tickets at the Hult Center cost more the night of the concert. All-State T-shirts will also be for sale in the hotel lobby.

14. **You must check out of your room by 1:00pm, Sunday.** A room will be provided for luggage storage. **Dress in your concert outfits prior to check-out.**

15. Participants will be instructed where to report for the concert by your organizing chairs. A room will be provided for storage of cases and coats. Do not leave purses or other valuables in this room. All-State Orchestra members will report directly to the Silva Concert Hall stage.

16. After your group has performed, you will be directed to an area of the concert hall to hear the rest of the concert. **You will be unable to get personal things from the storage room at the hotel until after the concert -- so please don't ask.**

CONTRACT

I hereby acknowledge and accept the following rules regarding the All-State Honor Groups. I agree to abide by these rules and all other policies, which have been adopted or may be adopted in the future by OMEA regarding this event.

I understand that OMEA has the sole discretion to make all decisions including, but not limited to, disciplinary matters and the final approval of students to perform.

I also promise that I will:

1. Learn all music before arriving in Eugene for the first rehearsal.
2. Protect and promptly return all music materials after the concert or upon request.
3. Attend all rehearsals and concerts on time. I understand that the only excuse for missing a rehearsal is illness and such illness or injury must be reported to the group manager and housing chairman. Any failure to attend a rehearsal will constitute grounds for exclusion from further participation, even though medical or other good reasons are given for the absence.
4. Cooperate fully with the clinician group manager, committee members, chaperones, and all other administration officials.
5. Neither use nor have in my possession at any time tobacco, alcoholic beverages or illegal drugs.
6. Not request a room change.
7. Not enter the hotel room of students of the opposite sex.
8. Not participate in vandalism or pranks of any kind.
9. Be in my assigned room at curfew time, and remain in my assigned room until wake-up time.
10. Wear proper identification at all times.
11. Conduct myself courteously and appropriately at all times.
12. Notify the group manager if I am compelled to withdraw for any reason.
13. Abide by all decisions made by the appropriate officials and obey all the regulations listed above as well as any other regulations which may be implemented in the future.

I understand that participating in an All-State Honor Group is a privilege and that my membership will be forfeited if I fail to comply with any of the above rules. I further understand that administrative officials have the right to exclude me from participation for any reason, including, but not limited to, failure to attend one or more rehearsals. If I am excluded, I will be asked to return home, my parents and school officials will be notified, **and my parents will be responsible to provide immediate transportation home. Students excluded from OMEA events for contract violations will not receive a refund of fees.**
